FINDINGS AND DECISION

On February 9, 2000, the Superintendent of Police filed charges with the Police Board of the City of Chicago against Crossing Guard Patricia M. Boncimino, Employee No. 521410 (hereinafter sometimes referred to as "Respondent"), for violating the following rules:

Rule 1: Violation of any law or ordinance.

Rule 2: Any action or conduct which impedes the Department's efforts to achieve its policy and goals or brings discredit upon the Department.

The Police Board of the City of Chicago investigated these charges and caused a hearing on these charges against Crossing Guard Patricia M. Boncimino to be had before Thomas E. Johnson, Hearing Officer of the Police Board of the City of Chicago, on June 8, 2000 and June 21, 2000.

Following the hearing, the members of the Police Board read and reviewed the certified transcription of the proceedings of the hearing. Thomas E. Johnson, Hearing Officer, made an oral report and conferred with the Police Board before it rendered a decision.

The Police Board of the City of Chicago, as a result of its investigation of the charges, finds and determines that:

1. The Respondent was at all times employed as a crossing quard by the Department of Police of the City of Chicago.

- 2. The charges were filed in writing and a Notice, stating the time, date and place, when and where a hearing of the charges was to be held, together with a copy of the original charges, was served upon the Respondent more than five (5) days prior to the hearing on the charges.
- 3. The hearing was conducted before Thomas E. Johnson, Hearing Officer of the Police Board of the City of Chicago, on June 8, 2000 and June 21, 2000.
- 4. Throughout the hearing, Crossing Guard Patricia M. Boncimino was present and was represented by counsel.
- 5. The Respondent Crossing Guard Patricia M. Boncimino, Employee No. 521410, charged herein, contrary to the Rules and Regulations, is <u>quilty</u> of violating to wit:

Rule 1: Violation of any law or ordinance, in that:

On or about May 26, 1999, civilian Stewart-Boncimino took possession of several bathing suits, valued at less than \$150.00, belonging to the Target store, located at 2656 N. Elston Avenue, Chicago, Illinois, a retail establishment, without paying for the merchandise, with the intent to deprive the owner permanently of the benefit or use of the merchandise, in violation of 720 ILCS 5/16-1(2)(A).

Rule 2: Any action or conduct which impedes the Department's efforts to achieve its policy and goals or brings discredit upon the Department, in that:

On or about May 26, 1999, civilian Stewart-Boncimino took possession of several bathing suits, valued at less than \$150.00, belonging to the Target store, located at 2656 N. Elston Avenue,

Chicago, Illinois, a retail establishment, without paying for the merchandise, with the intent to deprive the owner permanently of the benefit or use of the merchandise, in violation of 720 ILCS 5/16-1(2)(A).

By reason of the findings of fact, the Respondent is guilty of violating Rules 1 and 2. Cause exists for the separation of the Respondent Crossing Guard Patricia M. Boncimino, Employee No. 521410, from the Department of Police and from the services of the City of Chicago.
