CHARGES

Police Officer Robert Niziolek, Star Number 11878, is charged with violating the following rules contained in Article V of the Rules and Regulations of the Chicago Police Department, which were in full force and effect on the date of the alleged violations:

Rule 1: Violation of any law or ordinance;

Rule 2: Any action or conduct which impedes the Department's efforts to achieve its policy and goals or brings discredit upon the Department;

Rule 8: Disrespect to or maltreatment of any person, while on or off duty;

Rule 9: Engaging in any unjustified verbal or physical altercation with any person, while on or off duty;

Rule 15: Intoxication on or off duty.

SPECIFICATIONS

1. Police Officer Robert Niziolek, Star Number 11878, is charged with violating Rule 1, "Violation of any law or ordinance," in one or more of the following instances:

Count I: On or about January 27, 2000, at or near 11124 South Campbell Avenue and off duty, Officer Niziolek maltreated his former wife, Cathleen A. Niziolek, in that he struck and/or forcefully squeezed her hand and/or arm; and/or pulled her hair, causing and/or threatening to cause bodily harm to Ms. Niziolek in violation of Illinois Compiled Statutes chapter 720 ILCS 5/12-1 (Assault), and/or 720 ILCS 5/12-5 (Reckless Conduct), 720 ILCS 5/12-3 (Battery), and/or 720 ILCS 5/12-3.2 (Domestic Battery).

Count II: On or about February 20, 2000, at or near 11124 South Campbell Avenue and off duty, Officer Niziolek maltreated his former wife, Cathleen A. Niziolek, in that he shoved her, grabbed her hair and/or struck her one or more times on her head, face and/or back thus causing and/or threatening to cause bodily harm to Ms. Niziolek in violation of Illinois Compiled Statutes chapter 720 ILCS 5/12-1 (Assault), and/or 720 ILCS 5/12-5 (Reckless Conduct), 720 ILCS 5/12-3 (Battery), and/or 720 ILCS 5/12-3.2 (Domestic Battery).

Count III: On or about April 7, 2000, at or near 11124 South Campbell Avenue and

off duty, Officer Niziolek maltreated his former wife, Cathleen A. Niziolek, in that he threw her against a television set thus causing and/or threatening to cause bodily harm to Ms. Niziolek in violation of Illinois Compiled Statutes chapter 720 ILCS 5/12-1 (Assault), and/or 720 ILCS 5/12-5 (Reckless Conduct), 720 ILCS 5/12-3 (Battery), and/or 720 ILCS 5/12-3.2 (Domestic Battery).

- 2. Police Officer Robert Niziolek, Star Number 11878, is charged with violating Rule 2, "Any action or conduct which impedes the Department's efforts to achieve its policy and goals or brings discredit upon the Department," in one or more of the following instances:
- Count I: On or about January 27, 2000, at or near 11124 South Campbell Avenue and off duty, Officer Niziolek brought discredit upon the Department by causing and/or threatening to cause bodily harm to his former wife, Cathleen A. Niziolek, when he struck and/or forcefully squeezed her hand and/or arm, and/or when he pulled her hair.
- Count II: On or about February 20, 2000, at or near 11124 South Campbell Avenue and off duty, Officer Niziolek brought discredit upon the Department by causing and/or threatening to cause bodily harm to his former wife, Cathleen A. Niziolek, when he shoved her, grabbed her hair and/or struck her one or more times on her head, face and/or back.
- Count III: On or about April 7, 2000, at or near 11124 South Campbell Avenue and off duty, Officer Niziolek brought discredit upon the Department by causing and/or threatening to cause bodily harm to his former wife, Cathleen A. Niziolek, when he threw her against a television set.
- Count IV: On or about January 28, 2000, Officer Niziolek brought discredit upon the Department when he violated the Conditions of Bail Bond by not immediately surrendering all of his firearms to the Chicago Police Department.
- Count V: On or about February 20, 2000, Officer Niziolek brought discredit upon the Department when a Breath Alcohol Test administered to him revealed that he had a blood alcohol level of approximately 0.225%, thus being intoxicated.
- 3. Police Officer Robert Niziolek, Star Number 11878, is charged with violating Rule 8: "Disrespect to or maltreatment of any person, while on or off duty," in one or more of the following instances:

Count I: On or about January 27, 2000, at or near 11124 South Campbell Avenue and off duty, Officer Niziolek maltreated his former wife, Cathleen A. Niziolek, in that he struck and/or forcefully squeezed her hand and/or arm, and/or pulled her hair, causing and/or threatening to cause bodily harm to Ms. Niziolek.

Count II: On or about February 20, 2000, at or near 11124 South Campbell Avenue and off duty, Officer Niziolek maltreated his former wife, Cathleen A. Niziolek, in that he shoved her, grabbed her hair and/or struck her one or more times on her head, face and/or back thus causing and/or threatening to cause bodily harm to Ms. Niziolek.

Count III: On or about April 7, 2000, at or near 11124 South Campbell Avenue and off duty, Officer Niziolek maltreated his former wife, Cathleen A. Niziolek, in that he threw her against a television set thus causing and/or threatening to cause bodily harm to Ms. Niziolek.

4. Police Officer Robert Niziolek, Star Number 11878, is charged with violating Rule 9: "Engaging in any unjustified verbal or physical altercation with any person, while on or off duty," in one or more of the following instances:

Count I: On or about January 27, 2000, at or near 11124 South Campbell Avenue and off duty, Officer Niziolek engaged in an unjustified verbal and/or physical altercation with his former wife, Cathleen A. Niziolek, in that he struck and/or forcefully squeezed her hand and/or arm, and/or pulled her hair, causing and/or threatening to cause bodily harm to Ms. Niziolek.

Count II: On or about February 20, 2000, at or near 11124 South Campbell Avenue and off duty, Officer Niziolek engaged in an unjustified verbal and/or physical altercation with his former wife, Cathleen A. Niziolek, in that he shoved her, grabbed her hair and/or struck her one or more times on her head, face and/or back thus causing and/or threatening to cause bodily harm to Ms. Niziolek.

Count III: On or about April 7, 2000, at or near 11124 South Campbell Avenue and off duty, Officer Niziolek engaged in an unjustified verbal and/or physical altercation with his former wife, Cathleen A. Niziolek, in that he threw her against a television set thus causing and/or threatening to cause bodily harm to Ms. Niziolek.

5. Police Officer Robert Niziolek, Star Number 11878, is charged with violating Rule 15; "Intoxication on or off duty", in the following instance:

Count I:

On or about February 20, 2000, Officer Robert Niziolek submitted to a Breath Alcohol Test which results revealed that he had a blood alcohol level of approximately 0.225%, thus being intoxicated while off duty.

Based on the foregoing charges and specifications, the Superintendent recommends that Police Officer Robert Niziolek, Star Number 11878, be discharged from the Chicago Police Department.

Police Officer Robert Niziolek, Star Number 11878, is charged with violating the following rules contained in Article V of the Rules and Regulations of the Chicago Police Department, which were in full force and effect on the date of the alleged violations:

Rule 15: Intoxication on or off duty.

1. Police Officer Robert Niziolek, Star Number 11878, is charged with violating Rule 1, "Violation of any law or ordinance," in one or more of the following instances:

Count I: On or about January 27, 2000, at or near 11124 South Campbell Avenue and off duty, Officer Niziolek maltreated his former wife, Cathleen A. Niziolek, in that he struck and/or forcefully squeezed her hand and/or arm; and/or pulled her hair, causing and/or threatening to cause bodily harm to Ms. Niziolek in violation of Illinois Compiled Statutes chapter 720 ILCS 5/12-1 (Assault), and/or 720 ILCS 5/12-5 (Reckless Conduct), 720 ILCS 5/12-3 (Battery), and/or 720 ILCS 5/12-3.2 (Domestic Battery).

Count II: On or about February 20, 2000, at or near 11124 South Campbell Avenue and off duty, Officer Niziolek maltreated his former wife, Cathleen A. Niziolek, in that he shoved her, grabbed her hair and/or struck her one or more times on her head, face and/or back thus causing and/or threatening to cause bodily harm to Ms. Niziolek in violation of Illinois Compiled Statutes chapter 720 ILCS 5/12-1 (Assault), and/or 720 ILCS 5/12-5 (Reckless Conduct), 720 ILCS 5/12-3 (Battery), and/or 720 ILCS 5/12-3.2 (Domestic Battery).

Niziolek, when he struck and/or forcefully squeezed her hand and/or arm, and/or when he pulled her hair.
- Count II: On or about February 20, 2000, at or near 11124 South Campbell Avenue and off duty, Officer Niziolek brought discredit upon the Department by causing and/or threatening to cause bodily harm to his former wife, Cathleen A. Niziolek, when he shoved her, grabbed her hair and/or struck her one or more times on her head, face and/or back.
- Count III: On or about April 7, 2000, at or near 11124 South Campbell Avenue and off duty, Officer Niziolek brought discredit upon the Department by causing and/or threatening to cause bodily harm to his former wife, Cathleen A. Niziolek, when he threw her against a television set.
- Count IV: On or about January 28, 2000, Officer Niziolek brought discredit upon the Department when he violated the Conditions of Bail Bond by not immediately surrendering all of his firearms to the Chicago Police Department.
- Count V: On or about February 20, 2000, Officer Niziolek brought discredit upon the Department when a Breath Alcohol Test administered to him revealed that he had a blood alcohol level of approximately 0.225%, thus being intoxicated.
- 3. Police Officer Robert Niziolek, Star Number 11878, is charged with violating Rule 8: "Disrespect to or maltreatment of any person, while on or off duty," in one or more of the following instances:

Count I: On or about January 27, 2000, at or near 11124 South Campbell Avenue and off duty, Officer Niziolek maltreated his former wife, Cathleen A. Niziolek, in that he struck and/or forcefully squeezed her hand and/or arm, and/or pulled her hair, causing and/or threatening to cause bodily harm to Ms. Niziolek.

Count II: On or about February 20, 2000, at or near 11124 South Campbell Avenue and off duty, Officer Niziolek maltreated his former wife, Cathleen A. Count I: On or about January 27, 2000, at or near 11124 South Campbell Avenue and off duty, Officer Niziolek engaged in an unjustified verbal and/or physical altercation with his former wife, Cathleen A. Niziolek, in that he struck and/or forcefully squeezed her hand and/or arm, and/or pulled her hair, causing and/or threatening to cause bodily harm to Ms. Niziolek.

Count II: On or about February 20, 2000, at or near 11124 South Campbell Avenue and off duty, Officer Niziolek engaged in an unjustified verbal and/or physical altercation with his former wife, Cathleen A. Niziolek, in that he shoved her, grabbed her hair and/or struck her one or more times on her head, face and/or back thus causing and/or threatening to cause bodily harm to Ms. Niziolek.

Count III: On or about April 7, 2000, at or near 11124 South Campbell Avenue and off duty, Officer Niziolek engaged in an unjustified verbal and/or physical altercation with his former wife, Cathleen A. Niziolek, in that he threw her against a television set thus causing and/or threatening to cause bodily harm to Ms. Niziolek.

5. Police Officer Robert Niziolek, Star Number 11878, is charged with violating Rule 15; "Intoxication on or off duty", in the following instance:

Count I:

On or about February 20, 2000, Officer Robert Niziolek submitted to a Breath Alcohol Test which results revealed that he had a blood alcohol level of approximately 0.225%, thus being intoxicated while off duty.

Based on the foregoing charges and specifications, the Superintendent recommends that Police Officer Robert Niziolek, Star Number 11878, be discharged from the Chicago Police Department.
