### FINDINGS & DECISION

On April 6, 2001, the Superintendent of Police filed charges with the Police Board of the City of Chicago against Crossing Guard Tammy Brown, Star #3419-G, (hereinafter sometimes referred to as "Respondent") seeking the discharge of Respondent for violating the following Rules:

- Rule 1: Violation of any law or ordinance
- Rule 2: Any action or conduct which impedes the Department's efforts to achieve its policy and/or goals and/or brings discredit upon the Department.
- Rule 9: Engaging in any unjustified verbal or physical altercation with any person, while on or off duty.

The Police Board of the City of Chicago caused a hearing on these charges against Crossing Guard Tammy Brown to be had before Michael G. Berland, Hearing Officer of the Police Board of the City of Chicago on August 22, 2001 and October 3, 2001.

Following the hearing, the members of the Police Board read and reviewed the certified transcription of the proceedings of the hearing. Michael G. Berland, Hearing Officer, made an oral report and conferred with the Police Board before it rendered a decision.

of violating, to wit:

- Rule 2: Any action or conduct which impedes the Department's efforts to achieve its policy and/or goals and/or brings discredit upon the Department.
- A. On or about August 2, 2000, at approximately 2000 hours, while in the vicinity of 6531 S. Lowe, Chicago, Illinois, Crossing Guard Tammy Brown, while off duty, struck Lakeisha Cosey about the head and body, thereby impeding the Department's efforts to achieve its policy and goals and/or bringing discredit upon the Department.
- B. On or about October 3, 2000, Crossing Guard Tammy Brown pled guilty to the offense of battery, thereby impeding the Department's efforts to achieve its policy and goals and/or bringing discredit upon the Department.
- 7. Respondent Crossing Guard Tammy Brown, Star # 3419-G, charged herein, contrary to the Rules and Regulations, is guilty of violating, to wit:
- Rule 8: Disrespect to or maltreatment of any person, while on or off duty.
- A. On or about August 2, 2000, at approximately 2000 hours, while in the vicinity of 6531 S. Lowe, Chicago, Illinois, Crossing Guard Tammy Brown, while off duty, did disrespect and maltreat any person in that she struck Lakeisha Cosey about the head and body.
- 8. Respondent Crossing Guard Tammy Browne, Star #3419-G, charged herein, contrary to the Rules and Regulations, is guilty of violating, to wit:
  - A. On or about August 2, 2000, at approximately 2000 hours,

while in the vicinity of 6531 S. Lowe, Chicago, Illinois,
Crossing Guard Tammy Brown engaged in an unjustified verbal or
physical altercation with any person, while off duty, in that she
struck Lakeisha Cosey about the head and body.

By reason of the fact that Crossing Guard Tammy Brown, Star 3419-G, is guilty of violating Rules 1, 2, 8 and 9, cause exists for the suspension of Respondent Crossing Guard Tammy Brown, Star #3419-G, from her position with the Department of Police and from the services of the City of Chicago from April 7, 2001 to and including December 3, 2001 with restoration of all rights and benefits thereafter.


