FINDINGS AND DECISION

On September 12, 2002, the Superintendent of Police filed charges with the Police Board of the City of Chicago, seeking the separation of Police Officer KATHLEEN NELSON, Star #5475, hereinafter sometimes referred to as "Respondent" for violation of the following rules:

<u>RULE 1</u>	-	"Violation of any law or ordinance."
<u>RULE 2</u>	-	" Any action or conduct which impedes the Department's
		efforts to achieve its policy and goals or brings discredit
		upon the Department."
<u>RULE 8</u>	-	"Disrespect or maltreatment of any person, while on or off
		duty."
<u>RULE 9</u> -		"Engaging in any unjustified verbal or physical altercation
		with any person, while on or off duty."

<u>RULE 15</u> - "Intoxication on or off duty."

The Police Board of the City of Chicago, caused a hearing on these charges against Police Officer KATHLEEN NELSON, Star #5475 to be heard by JACQUELINE A. WALKER, Hearing Officer of the Police Board of the City of

Chicago, on January 17, 2003 and January 28, 2003. Additionally, on December 19,

2003, on the remand of Cook County Circuit Court Judge Dorothy Kirie Kinnaird, a hearing was held in mitigation and aggravation pertaining to the charges. Following the Hearing, the members of the Police Board read and reviewed the certified transcription of the proceedings of the hearing, and viewed the videotape of the hearing in mitigation and aggravation. JACQUELINE A. WALKER, Hearing Officer made an oral report and conferred with the Police Board before it rendered a decision.

As a result of the foregoing, the Police Board of the City of Chicago finds and determines that:

- The Respondent was, at all times mentioned herein, a Police Officer employed by the Department of Police of the City of Chicago;
- (2) The charges were filed, in writing, and a Notice, stating the time, date and place, when and where a hearing in the charges was to be held, together with a copy of the original charges were served upon the Respondent more than five (5) days prior to the hearing on the charges;
- (3) Throughout the hearing, the Respondent appeared in person and was represented by legal counsel;
- (4) The Respondent, Police Officer KATHLEEN NELSON, Star 5475, as charged herein, is guilty of violating, to-wit:

<u>**RULE 1**</u> - "Violation of any law or ordinance", in the following instances:

A. On or about December 22, 2001, at approximately 1830 hours, at or near One Old Orchard Mall in Skokie, Illinois, while off duty, she directed one and/or more profanities towards one and/or more members of the Skokie Police Department, and/or on duty Skokie Fire Department personnel, and/or members of the public, in violation of Illinois Compiled Statutes, Chapter 720 Section 5/26-1(a) (1);

- B. On or about December 22, 2001, at approximately 1830 hours, at or near One
 Old Orchard Mall in Skokie, Illinois, while off duty, she kicked Skokie Police
 Sergeant Fred Brehmer, at or near the groin area, in violation of Illinois
 Complied Statutes, Chapter 720, Section 5/26-1 (a) (1) and Chapter 720 Section 5/12-4(b)(6);
- C. On or about December 22, 2001, at approximately 1830 hours, at or near One Old Orchard Mall in Skokie, Illinois, while off duty, she kicked and/or struggled with on duty Skokie Police Officers during the course of her arrest, in violation of Illinois Complied Statutes, Chapter 720 Section 5/26-1(a)(1).

(5) The Respondent, Police Officer KATHLEEN NELSON, Star #5475, as charged herein, is guilty of violating, to-wit:

- **<u>RULE 2</u>** "Any action or conduct which impedes the Department's efforts to achieve its policy and goals or brings discredit upon the Department", in the following instances:
- A. On or about December 22, 2001, at approximately 1830 hours, at or near One Old Orchard Mall in Skokie, Illinois, while off duty, she, among other things, refused to cooperate with one and/or more verbal requests made by one and/or more on-duty Skokie Fire Department Personnel, and/or one and/or more Skokie Police Officers;

- B. On or about December 22, 2001, at approximately 1830 hours, at or near One
 Old Orchard Mall in Skokie, Illinois, while off duty, she, among other things,
 directed one and/or more profanities towards one and/or more members of the
 Skokie Police Department, and/or on duty Skokie Fire Department personnel,
 and/or members of the public;
- C. On or about December 22, 2001 at approximately 1830 hours, at or near One Old Orchard Mall in Skokie, Illinois, while off duty, she, among other things, kicked Skokie Police Sergeant Fred Brehmer at or near the groin area, in violation of Illinois Compiled Statutes Chapter 720 Section 5/12-4(b)(6);

(6) The Respondent, Police Officer **KATHLEEN NELSON**, Star #5475, as charged herein, is **guilty** of violating, to-wit:

<u>RULE 8</u> – "Disrespect to or maltreatment of any person while on or off duty", in the following instances:

- A. On or about December 22, 2001, at approximately 1830 hours, at or near Old Orchard Mall in Skokie Illinois, while off duty, she refused to cooperate with one and/or more members of the Skokie Fire Department personnel and one and/or more members of the Skokie Police Department;
- B. On or about December 22, 2001, at approximately 1830 hours, at or near One
 Old Orchard Mall in Skokie, Illinois, while off duty, she directed one and/or
 more profanities towards one and/or more members of the Skokie Police
 Department and one and/or more on duty Skokie Fire Department personnel
 and/or members of the public;
- C. On or about December 22, 2001, at approximately 1830 hours, at or near One Orchard Mall in Skokie, Illinois, while off duty, she kicked Skokie Police Sergeant Fred Bremher at or near the groin area;
- D. On or about December 22, 2001, at approximately 1830 hours, at or near One
 Old Orchard Mall in Skokie, Illinois, while off duty, she kicked and/or struggled
 with on duty Skokie Police Officers during the course of her arrest.

(7) The Respondent, Police Officer **KATHLEEN NELSON**, Star #5475, as charged herein, is **guilty** of violating, to-wit:

<u>RULE 9</u> – "Engaging in any unjustified verbal or physical alteration with any person while on or off duty" in the following instances:

- A. On or about December 22, 2001, at approximately 1830 hours, at or near One
 Old Orchard Mall in Skokie, Illinois, while off duty, she engaged in an
 unjustified verbal altercation with one and/or more on duty Skokie Police
 Officers and/or on duty Skokie Fire Department personnel, whereby she refused
 to cooperate with one and/or more verbal requests;
- B. On or about December 22, 2001, at approximately 1830 hours, at or near One Old Orchard Mall in Skokie, Illinois, while off duty; she engaged in an unjustified verbal altercation with one and/or more members of the Skokie Police Department and/or on duty Skokie Fire Department personnel, and/or members of the public, whereby she directed one and/or more profanities towards one and/or more individuals;
- C. On or about December 22, 2001, at approximately 1830 hours, at or near One Old Orchard Mall in Skokie, Illinois, while off duty, she engaged in an unjustified physical altercation with Skokie Police Sergeant Fred Brehmer, whereby she kicked him at or near the groin area;
- D. On or about December 22, 2001 at approximately 1830 hours, at or near Old Orchard Mall in Skokie, Illinois, while off duty, she engaged in an unjustified physical altercation with one and/or more on duty Skokie Police Officers, whereby she kicked and/or struggled during the course of her arrest.

(8) The Respondent, Police Officer **KATHLEEN NELSON**, Star #5475, as charged herein, is <u>guilty</u> of violating, to-wit:

<u>RULE 15</u> – "Intoxication on or off duty", in that:

On or about December 23, 2001, at approximately 0056 hours, at or near the 14th District of the Chicago Police Department, while off duty, she was administered a Breathalyzer test and the results were .202, thereby indicating she was intoxicated.

BY REASON of these findings of fact, the Police Board of the City of Chicago found the respondent guilty of violating Rules 1, 2, 8, 9, and 15, and separated her from her position as a Police Officer within the Police Department of the City of Chicago.

Police Officer Nelson then timely sought administrative review of the Police Board's decision in the Circuit Court of Cook County. On September 19, 2003, Circuit Court Judge Dorothy Kirie Kinnaird entered her Order, stating that the board's decision that cause exists for petitioner's discharge was arbitrary, unreasonable, and unrelated to the requirements of the service under the specific facts of this case, and considering petitioner's history with the Department and treatment of her condition. Circuit Court Judge Kinnaird remanded the matter to the Police Board of the City of Chicago for consideration of a penalty less than discharge.

DECISION

The members of the Police Board have read and reviewed the certified copy of the transcription of the hearing, having viewed the videotapes of the hearing, have received a new oral report of the Hearing Officer, JACQUELINE A. WALKER, and have conferred with the Hearing Officer on the credibility of the witnesses and the evidence, have reviewed the findings set forth above, and have reviewed the order of Judge Dorothy Kirie Kinnaird of the Circuit Court of Cook County, dated September 19, 2003.

The Police Board has again considered all of the evidence in this case, including the testimony, exhibits, and departmental complimentary and disciplinary history. The Police Board remains convinced that Police Officer Nelson's conduct renders her unfit for employment as a Police Officer the Police Department of the City of Chicago.

In order to comply with the Order of the Circuit Court of Cook County, the Police Board will impose a penalty on Police Officer Nelson of less than separation. The Police Board does so solely to permit appellate review of the Circuit Court's Decision in this matter, and urges the Superintendent of Police to seek such review.

IT IS HEREBY ORDERED that the Respondent, **Police Officer Kathleen Nelson**, Star # 5475, as a result of having been found guilty of the charges in Police Board Case No. 02-2500, is hereby suspended from her position as a Police Officer, and from the services of the City of Chicago, from September 13, 2002, to and including March 13, 2005.

BY REASON of the findings of fact and of guilt herein, cause exists for the separation and discharge of Respondent, Police Officer KATHLEEN NELSON, Star #

5475, from the Department of Police and from the services of the City of Chicago.





- Rule 15: Intoxication on or off duty.

SPECIFICATIONS

- 1. Police Officer Kathleen Nelson, Star Number 5475, is charged with violating Rule 1, "Violation of any law or ordinance" in the following instance:
 - Count I: On or about December 22, 2001, at approximately 1830 hours, at or near One Old Orchard Mall in Skokie, Illinois, Officer Nelson, while off duty, directed one and/or more profanities towards one and/or more members of the Skokie Police Department, and/or on duty Skokie Fire Department personnel, and/or members of the <u>public</u> in violation of Illinois Compiled Statutes Chapter 720 Section 5/26-1(a)(1);
 - Count II: On or about December 22, 2001, at approximately 1830 hours, at or near One Old Orchard Mall in Skokie, Illinois, Officer Nelson, while off duty, kicked Skokie Police Sergeant Fred Brehmer at or near the groin area, in violation of Illinois Compiled Statutes Chapter 720 Section 5/26-1(a)(1) and Chapter 720 Section 5/12-4(b)(6);

 - Count I: On or about December 22, 2001, at approximately 1830 hours, at or near One Old Orchard Mall in Skokie, Illinois, Officer Nelson, while off duty, brought discredit upon the department and impeded the Department's efforts to achieve its policy and goals in that she, among other things, refused to cooperate with one and/or more verbal requests made by one and/or more on-duty Skokie Fire Department Personnel, and/or one and/or more Skokie Police Officers;
 - Count II: On or about December 22, 2001, at approximately 1830 hours, at or near One Old Orchard Mall in Skokie, Illinois, Officer Nelson, while off duty, brought discredit upon the department and impeded the Department's efforts to achieve its policy and goals in that she, among other things, directed one and/or more profanities towards one and/or more members of the Skokie Police Department, and/or on duty Skokie Fire Department personnel, and/or members of the public;
 - Count III: On or about December 22, 2001, at approximately 1830 hours, at or near One Old Orchard Mall in Skokie, Illinois, Officer Nelson, while off duty, brought discredit upon the department and impeded the Department's efforts to achieve its policy and goals in that she, among other things, kicked Skokie Police Sergeant Fred Brehmer at or near the groin area, in violation of Illinois Compiled Statutes Chapter 720 Section 5/12-4(b)(6):
 - Count IV: On or about December 22, 2001, at approximately 1830 hours, at or near One Old Orchard Mall in Skokie, Illinois, Officer Nelson, while off duty, brought discredit upon the department and impeded the Department's efforts to achieve its policy and goals in that she, among other things, kicked and/or struggled with on duty Skokie Police Officers during the course of her arrest;
 - Count V: On or about December 22, 2001, at approximately 1830 hours, at or near One Old Orchard Mall in Skokie, Illinois, Officer Nelson, while off duty, brought discredit upon the department and impeded the Department's efforts to achieve its policy and goals in that she, among other things, kicked a display case within the Marshall Field's department store;
 - Count VI: On or about December 22, 2001, at approximately 1830 hours, at

or near One Old Orchard Mall in Skokie, Illinois, Officer Nelson, while off duty, brought discredit upon the department and impeded the Department's efforts to achieve its policy and goals in that she, among other things, was intoxicated in a public establishment.

- Police Officer Kathleen Nelson, Star Number 5475, is charged with violating Rule
 8, "Disrespect or maltreatment of any person, while on or off duty," in one or more of the following instances:
 - Count I: On or about December 22, 2001, at approximately 1830 hours, at or near One Old Orchard Mall in Skokie, Illinois, Officer Nelson, while off duty, refused to cooperate with one and/more verbal requests made by one and/more members of the Skokie Fire Department Personnel, and/or members of the Skokie Police Department, thereby being disrespectful to or maltreating any person, while on or off duty;
 - Count II: On or about December 22, 2001, at approximately 1830 hours, at or near One Old Orchard Mall in Skokie, Illinois, Officer Nelson, while off duty, directed one and/or more profanities towards one and/or more members of the Skokie Police Department, and/or on duty Skokie Fire Department personnel, and/or members of the public, thereby being disrespectful to or maltreating any person, while on or off duty;
 - Count III: On or about December 22, 2001, at approximately 1830 hours, at or near One Old Orchard Mall in Skokie, Illinois, Officer Nelson, while off duty, kicked Skokie Police Sergeant Fred Brehmer at or near the groin area, thereby being disrespectful to or maltreating any person, while on or off duty;
 - Count IV: On or about December 22, 2001, at approximately 1830 hours, at or near One Old Orchard Mall in Skokie, Illinois, Officer Nelson, while off duty, kicked and/or struggled with on duty Skokie Police Officers during the course of her arrest, thereby being disrespectful to or maltreating any person, while on or off duty;
- Police Officer Kathleen Nelson, Star Number 5475, is charged with violating Rule
 9, "Engaging in any unjustified verbal or physical alteration with any person while on or off duty," in one or more of the following instances:
 - Count I: On or about December 22, 2001, at approximately 1830 hours, at or near One Old Orchard Mall in Skokie, Illinois, Officer Nelson, while off duty, engaged in an unjustified verbal altercation with one and/or more on duty Skokie Police Officers, and/or one more on duty Skokie Fire Department Personnel, whereby she refused to

cooperate with one and/or more verbal requests;

- Count II: On or about December 22, 2001, at approximately 1830 hours, at or near One Old Orchard Mall in Skokie, Illinois, Officer Nelson, while off duty, engaged in an unjustified verbal altercation with, one and/or more members of the Skokie Police Department, and/or on duty Skokie Fire Department personnel, and/or members of the public, whereby she directed one and/or more profanities towards one and/or more individuals;
- Count III: On or about December 22, 2001, at approximately 1830 hours, at or near One Old Orchard Mall in Skokie, Illinois, Officer Nelson, while off duty, engaged in an unjustified physical altercation with Skokie Police Sergeant Fred Brehmer, whereby she kicked him at or near the groin area;
- Count IV: On or about December 22, 2001, at approximately 1830 hours, at or near One Old Orchard Mall in Skokie, Illinois, Officer Nelson, while off duty, engaged in an unjustified physical altercation with one and/or more on duty Skokie Police Officers, whereby she kicked and/or struggled during the course of her arrest.
- 5. Police Officer Kathleen Nelson, Star Number 5475, is charged with violating Rule 15, "Intoxication on or off duty," in one of more of the following instances:
 - Count I: On or about December 22, 2001, at approximately 1830 hours, at or near One Old Orchard Mall in Skokie, Illinois, Officer Nelson, while off duty, was intoxicated.

Based on the foregoing charges and specifications, the Superinterster the recommends that Police Officer Kathleen Nelson, Star Number 5475, be discharged from the Chicago Police Department.
