CHARGES

Police Officer Turan M. Beamon, Star Number 6734, is charged with violating the following rules contained in Article V of the Rules and Regulations of the Chicago Police Department, which were in full force and effect on the date of the alleged violations:

Rule 1: Violation of any law or ordinance.

Rule 2: Any action or conduct which impedes the Department's

efforts to achieve its policy and goals or brings discredit

upon the Department.

SPECIFICATIONS

Police Officer Turan M. Beamon, Star Number 6734, is charged with violating Rule 1, "Violation of any law or ordinance," in one or more of the following instances:

Count I: Beginning on or about 29 August 2002, Police Officer

Beamon committed the offense of Conspiracy when with the intent to commit a Theft, Police Officer Beamon agreed with another to commit that offense, thereby

violating 720 ILCS 5/8-2.

Count II: On or about 5 September 2002, at or near the Country

Inn and Suites Hotel, 1265 Lakeview Drive, Romeoville, Illinois, Police Officer Beamon committed the offense of Theft when he knowingly obtained or exerted unauthorized control over \$10,000 United States currency contained in a red metal tool box from the trunk of a motor vehicle, intending to deprive the owner permanently of the use or benefit of the money, thereby

violating 720 ILCS 5/16-1(A).

Count III: On or about 5 September 2002, at or near the Country

Inn and Suites Hotel, 1265 Lakeview Drive, Romeoville, Illinois, Police Officer Beamon committed the offense of Burglary, when without authority, he knowingly entered a motor vehicle, with the intent to commit a felony or a theft and removed \$10,000 United States currency contained in a red metal tool box from the trunk of a

motor vehicle, thereby violating 720 ILCS 5/19-1.

Count IV:

On or about 5 September 2002, at or near the Country Inn and Suites Hotel, 1265 Lakeview Drive, Romeoville, Illinois, Police Officer Beamon committed the offense of Theft of Public Money in that Police Officer Beamon did steal \$10,000 in United States currency contained in a tool box he removed from a covert motor vehicle, said currency being United States government funds, thereby violating Title 18 United States Code, Chapter 31. Section 641.

Police Officer Turan M. Beamon, Star Number 6734, is charged with violating Rule 2, "Any action or conduct which impedes the Department's efforts to achieve its policy and goals or brings discredit upon the Department," in one or more of the following instances:

Count I:

Beginning on or about 29 August 2002, Police Officer Beamon committed the offense of Conspiracy when with the intent to commit a Theft, Police Officer Beamon agreed with another to commit that offense, thereby engaging in conduct which impedes the Department's efforts to achieve its policy and goals and/or bringing discredit upon the Department.

Count II:

On or about 5 September 2002, at or near the Country Inn and Suites Hotel, 1265 Lakeview Drive, Romeoville, Illinois, Police Officer Beamon committed the offense of Theft when he knowingly obtained or exerted unauthorized control over \$10,000 United States currency contained in a red metal tool box in the trunk of a motor vehicle, intending to deprive the owner permanently of the use or benefit of the money, thereby engaging in conduct which impedes the Department's efforts to achieve its policy and goals and/or bringing discredit upon the Department.

Count III:

On or about 5 September 2002, at or near the Country Inn and Suites Hotel, 1265 Lakeview Drive, Romeoville, Illinois, Police Officer Beamon committed the offense of Burglary, when without authority, he knowingly entered a motor vehicle, with the intent to commit a felony or a theft and removed \$10,000 United States currency contained in a red metal tool box from the trunk of the vehicle, thereby engaging in conduct which impedes the

Department's efforts to achieve its policy and goals and/or bringing discredit upon the Department.

Count IV:

On or about 5 September 2002, at or near the Country Inn and Suites Hotel, 1265 Lakeview Drive, Romeoville, Illinois, Police Officer Beamon committed the offense of Theft of Public Money in that Police Officer Beamon did steal \$10,000 in United States currency contained in a tool box he removed from a covert motor vehicle, said currency being United States government funds, thereby engaging in conduct which impedes the Department's efforts to achieve its policy and goals and/or bringing discredit upon the Department.

Based on the foregoing charges and specifications, the Superintendent of Police recommends that Police Officer Turan M. Beamon, Star Number 6734, be separated from the Chicago Police Department.
