CHARGES

Police Officer Lorne Porter, Employee Number 29167, is charged with violating the following rules contained in Article V of the Rules and Regulations of the Chicago Police Department, which were in full force and effect on the date of the alleged violations:

Rule 1: Violation of any law or ordinance

Rule 2: Any action or conduct which impedes the Department's efforts to achieve

its policy and goals or brings discredit upon the Department

SPECIFICATIONS

1. Police Officer Lorne Porter, Employee Number 29167, is charged with violating Rule 1, "Violation of any law or ordinance," in the following instance:

Count I:

On or about July 5, 2004, Police Officer Lorne Porter wrote a check in the amount of \$2,000.000 to "Self" from a Chicago Patrolmen's Federal Credit Union (CPFCU) checking account and deposited the check into an account, at approximately 1:26 A.M., while at a Seaway National Bank ATM, located at or near 8652 South Lafayette, Chicago, Illinois, with the knowledge that the CPFCU checking account had insufficient funds to support his transaction, thereby violating Chapter 720 ILCS 5/17-1(B)(d), by committing the act of Deceptive Practices.

Count II:

On or about July 5, 2004, at approximately 1:27 A.M., while at a Seaway National Bank ATM located at or near 8652 South Lafayette, Chicago, Illinois, Police Officer Lorne Porter withdrew the amount of \$400.00 from his Chicago Patrolmen's Federal Credit Union (CPFCU) checking account, with the knowledge that his CPFCU checking account had insufficient funds to support his transaction, thereby violating Chapter 720 ILCS 5/16-1(a)(2), by committing the act of Theft.

Count III:

On or about July 6, 2004, at approximately 3:34 P.M., while at an ATM located at or near 9434 South Halstead Street, Chicago, Illinois, Police Officer Lorne Porter withdrew the amount of approximately \$400.00 from his Chicago Patrolmen's Federal Credit Union (CPFCU) checking account, with the knowledge that his CPFCU checking account had insufficient funds to support his transaction, thereby violating Chapter 720 ILCS 5/16-1(a)(2), by committing the act of Theft.

2. Police Officer Lorne Porter, Employee Number 29167, is charged with violating Rule 2, "Any action or conduct which impedes the Department's efforts to achieve its policy and goals or brings discredit upon the Department," in the following instance:

Count I:

On or about July 5, 2004, Police Officer Lorne Porter wrote a check in the amount of \$2,000.000 to "Self" from a Chicago Patrolmen's Federal Credit Union (CPFCU) checking account and deposited the check into an account, at approximately 1:26 A.M., while at a Seaway National Bank ATM, located at or near 8652 South Lafayette, Chicago, Illinois, with the knowledge that the CPFCU checking account had insufficient funds to support his transaction, thereby impeding the Department's efforts to achieve its policy and goals and/or bring discredit upon the Department.

Count II:

On or about July 5, 2004, at approximately 1:27 A.M., while at a Seaway National Bank ATM located at or near 8652 South Lafayette, Chicago, Illinois, Police Officer Lorne Porter withdrew the amount of \$400.00 from his Chicago Patrolmen's Federal Credit Union (CPFCU) checking account, with the knowledge that his CPFCU checking account had insufficient funds to support his transaction, thereby impeding the Department's efforts to achieve its policy and goals and/or bringing discredit upon the Department.

Count III:

On or about July 6, 2004, at approximately 3:34 P.M., while at an ATM located at or near 9434 South Halstead Street, Chicago, Illinois, Police Officer Lorne Porter withdrew the amount of approximately \$400.00 from his Chicago Patrolmen's Federal Credit Union (CPFCU) checking account, with the knowledge that his CPFCU checking account had insufficient funds to support his transaction, thereby impeding the Department's efforts to achieve its policy and goals and/or bringing discredit upon the Department.

Based on the foregoing charges and specifications, the Superintendent recommends that Police Officer Lorne Porter, Employee Number 29167, be discharged from the Chicago Police Department.
