FINDINGS AND DECISION

On April 27, 2006, the Superintendent of Police filed charges with the Police Board of the City of Chicago seeking the discharge of **SIGMUND NASZKE JR.**, Star No. 11423, hereinafter sometimes referred to as "Respondent," for violation of the following rules:

- **RULE 1-** "Violation of any law or ordinance."
- RULE 2 "Any action or conduct which impedes the Department's efforts to achieve its policy and goals or brings discredit upon the Department."
- **RULE 6-** "Disobedience of an order or directive, whether written or oral."
- **RULE 8-** "Disrespect to or maltreatment of any person, while on or off-duty.
- **RULE 9-** "Engaging in any unjustified verbal or physical altercation with any person, while on or off duty."
- **RULE 14** "Making a false report, written or oral."

The Police Board of the City of Chicago caused a hearing on these charges against Police Officer **SIGMUND NASZKE**, Star No. 11423, to be heard by

JACQUELINE A. WALKER, Hearing Officer of the Police Board of the City of Chicago, on January 17, 2007, January 18, 2007, February 15, 2007 and March 1, 2007.

Following the Hearing, the members of the Police Board read and reviewed the certified transcription of the proceedings of the hearing and viewed the video recordings of the hearing. JACQUELINE A. WALKER, Hearing Officer made an oral report to and conferred with the Police Board before it rendered a decision.

As a result of the foregoing, the Police Board of the City of Chicago finds and determines that:

- (1) The Respondent was, at all times mentioned herein, a Police Officer employed by the Department of Police of the City of Chicago;
- (2) The charges were filed, in writing, and a Notice, stating the time, date and place, when and where a hearing on the charges was to be held, together with a copy of the original charges were served upon the Respondent more than five (5) days prior to the hearing on the charges;
- (3) Throughout the hearing, the Respondent appeared in person and was represented by legal counsel;
- (4) Respondent, Police Officer **SIGMUND NASZKE**, Star No. 11423, as charged herein, is **guilty** of violating, to-wit:

RULE 1: "Violation of any law or ordinance." in one or more of the following instances:

A) On or about August 22, 2004, at approximately 2:35 p.m., at or near 447 East Superior Street, Chicago, Illinois, while off-duty, he drove

- his black BMW, license plate number 5651294, on the sidewalk, in violation of Chapter 9-40-070 of the Chicago Municipal Code.
- B) On or about August 22, 2004, at approximately 2:35 p.m., at or near 447 East Superior Street, Chicago, Illinois, while off-duty, he drove his black BMW, license plate number 5651294, on the sidewalk, with disregard for the safety of people and/or property, in violation of 625 ILCS 5/11-503 of the Illinois Vehicle Code.
- C) On or about August 22, 2004, at approximately 2:35 p.m., at or near 447 East Superior Street, Chicago, Illinois, while off-duty, he failed to exercise due care to avoid colliding with any pedestrian when he drove his black BMW, license plate number 5651294, on the sidewalk and struck Tammy Blissett on her hip or thigh, in violation of Chapter 9-40-160 of the Chicago Municipal Code.
- D) On or about August 22, 2004, at approximately 2:35 p.m., at or near 447 East Superior Street, Chicago, Illinois, while off-duty, he failed to yield the right of way to a pedestrian when he drove his black BMW, license plate number 5651294, on the sidewalk and struck Tammy Blissett on her hip or thigh, in violation of 625 ILCS 5/11-1008 of the Illinois Vehicle Code.
- E) On or about August 22, 2004, at approximately 2:35 p.m., at or near 447 East Superior Street, Chicago, Illinois, while off-duty, he failed to exercise due care to avoid colliding with any pedestrian when he drove his black BMW, license plate number 5651294, on the sidewalk and

struck Tammy Blissett on her hip or thigh, in violation of 625 ILCS 5/11-1003.1 of the Illinois Vehicle Code.

- (5) Respondent, Police Officer **SIGMUND NASZKE, JR.,** Star No.11423, as charged herein, is **guilty** of violating, to wit:
 - **RULE 2**: "Any action or conduct which impedes the Department's efforts to achieve its policy and goals or brings discredit upon the Department," in one or more of the following instances:
 - (A) On or about August 22, 2004, at approximately 2:35 p.m., at or near 447 East Superior Street, Chicago, Illinois, while off-duty, he drove his black BMW, license plate number 5651294, on the sidewalk.
 - (B) On or about August 22, 2004, at approximately 2:35 p.m., at or near 447 East Superior Street, Chicago, Illinois, while off-duty, he drove his black BMW, license plate number 5651294, on the sidewalk with disregard for the safety of people and/or property.
 - (C) On or about August 22, 2004, after 2:35 p.m., at or near 447 East Superior Street, Chicago, Illinois, while off-duty, he failed to exercise due care to avoid colliding with any pedestrian when he drove his black BMW, license plate number 5651294, on the sidewalk and struck Tammy Blissett on her hip or thigh
 - (D) On or about August 22, 2004, after 2:35 p.m., at or near 447 East

 Superior Street, Chicago, Illinois, while off-duty, he failed to yield the right of way to a pedestrian when he drove his black BMW, license

plate number 5651294, on the sidewalk and struck Tammy Blissett on her hip or thigh.

- (E) On or about August 22, 2004, after 2:35 p.m., at or near 447 East Superior Street, Chicago, Illinois, while off-duty, he disobeyed an order or directive from Sergeant Diego Flores, Star No. 910, to go to the emergency room at Northwestern Hospital, and to wait for him there.
- (6) Respondent, Police Officer **SIGMUND NASZKE**, **JR.**, Star No.11423, as charged herein, is **guilty** of violating, to wit:

RULE 6: "Disobedience of an order or directive, whether written or oral," in that:

On or about August 22, 2004, after 2:35 p.m., at or near 447 East Superior Street, Chicago, Illinois, while off-duty, he disobeyed an order or directive from Sergeant Diego Flores, Star No. 910, to go to the emergency room at Northwestern Hospital and to wait for him there.

(7) Respondent, Police Officer **SIGMUND NASZKE, JR.,** Star No.11423, as charged herein, is **guilty** of violating, to wit:

RULE 8: "Disrespect to or maltreatment of any person, while on or off-duty," in one or more of the following instances:

(A) On or about August 22, 2004, after 2:35 p.m., at or near 447 East Superior Street, Chicago, Illinois, while off-duty, he disrespected and/or maltreated Tammy Blissett when he said

- and/or yelled "You fat ass fucking bitch get out of my way," and/or "Your fat ass needs to see Jenny Craig," and/or "I know you're on welfare," and/or "I'll bet you don't have insurance," or words to that effect.
- (B) On or about August 22, 2004, at approximately 2:35 p.m., at or near 447 East Superior Street, Chicago, Illinois, while off duty, he disrespected and/or maltreated Tammy Blissett when he struck her on her hip or thigh with his black BMW, license plate number 5651294.
- (8) Respondent, Police Officer **SIGMUND NASZKE**, **JR.**, Star No.11423, as charged herein, is **guilty** of violating, to wit:
- **RULE 9:** "Engaging in any unjustified verbal or physical altercation with any person, while on or off-duty," in one or more of the following instances:
 - (A) On or about August 22, 2004, after 2:35 p.m., at or near 447

 East Superior Street, Chicago, Illinois, while off-duty, he engaged in an unjustified verbal altercation with Tammy

 Blissett, when he said and/or yelled, "You fat ass fucking bitch get out of my way," and/or "Your fat ass needs to see Jenny

 Craig," and/or "I know you're on welfare," and/or "I'll bet you don't have insurance," or words to that effect.
 - (B) On or about August 22, 2004, after 2:35 p.m., at or near 447

 East Superior Street, Chicago, Illinois, while off-duty, he engaged in an unjustified physical altercation with Tammy

Blissett when he struck her on her hip or thigh with his black BMW, license plate number 5651294.

(9) Respondent, Police Officer **SIGMUND NASZKE**, **JR.**, Star No.11423, as charged herein, is **guilty** of violating, to wit:

RULE 14: "Making a false report, written or oral," in one or more of the following instances:

- (A) On or about January 14, 2005, and September 19, 2005, he made false statements to Internal Affairs Division Investigator Sergeant Barbara West when he stated that on August 22, 2004, at approximately 2:35 p.m., at or near 447 East Superior Street, Chicago, Illinois, he did not drive his black
 BMW, license plate number 5651294, on the sidewalk.
- (B) On or about January 14, 2005, he made a false statement to Internal Affairs Division Investigator Sergeant Barbara West regarding August 22, 2004, at approximately 2:35 p.m., at or near 447 East Superior Street, Chicago, Illinois, when he was asked, "did you inform Sergeant Flores your passenger was in need of medical attention and you were taking her to Northwestern Hospital?" and he answered "No."
- (C) On or about January 14, 2005, he made a false statement to Internal Affairs Division Investigator Sergeant Barbara West regarding August 22, 2004, at approximately 2:35 p.m., at or near 447 East Superior Street, Chicago, Illinois, when he was

asked, "Did you inform the officers working Beat 4584 that

your female passenger needed to go to the hospital?" and he

answered "No."

(D) On or about September 19, 2005, he made a false statement

Internal Affairs Division Investigator Sergeant Barbara West

regarding August 22, 2004, at approximately 2:35 p.m., at or

near 447 East Superior Street, Chicago, Illinois, when he was

asked, "At any time did you inform P.O. James Woods, Star

No. 12813, that you had to take your female passenger, Lidia

Delvalle, who was ill to the hospital?" and he answered "No."

BY REASON of the findings of fact and of guilt herein, cause exists for the

discharge of Respondent, Police Officer SIGMUND NASZKE, JR., Star No.11423,

from his position as a police officer with the Department of Police, and from the services

of the City of Chicago.






