FINDINGS AND DECISION

On January 5, 2007, the Superintendent of Police filed charges with the Police Board of the City of Chicago, seeking the termination of Police Officer MeShay Owens, Star #7737, hereinafter sometimes referred to as "Respondent" for violation of the following rules:

RULE 3: "Any failure to promote the Department's efforts to implement its policy or accomplish its goals."

RULE 6: "Disobedience of an order or directive, whether written or oral."

RULE 22: "Failure to report to the Department any violation of Rules and Regulations or any other improper conduct which is contrary to policy, orders or directives of the Department."

The Police Board of the City of Chicago caused a hearing on these charges against Police Officer Meshay Owens, Star No.7737, to be heard by Jacqueline A. Walker, Hearing Officer of the Police Board of the City of Chicago, on May 10, 2007, May 15, 2007, May 30, 2007 and June 19, 2007. Following the Hearing, the members of the Police Board read and reviewed the certified transcription of the proceedings of the hearing and viewed the videotapes of the proceedings. Jacqueline A. Walker, Hearing Officer made an oral report and conferred with the Police Board before it rendered a decision.

As a result of the foregoing, the Police Board of the City of Chicago finds and determines that:

- (1) The Respondent was, at all times mentioned herein, a Police Officer employed by the Department of Police of the City of Chicago;
- (2) The charges were filed, in writing, and a Notice, stating the time, date and place, when and where a hearing on the charges was to be held, together with a copy of the original charges were served upon the Respondent more than five (5) days prior to the hearing on the charges;
- (3) Throughout the hearing, the Respondent appeared in person and was represented by legal counsel;
- (4) Respondent, Police Officer MeShay Owens, Star No. 7737, as charged herein, is **not guilty** of violating, to-wit:
- RULE 3: Any failure to promote the Department's efforts to implement it policy or accomplish its goals.
 - (A) The Superintendent did not prove by a preponderance of evidence that on or about October 20, 2004, at approximately 1900 hours, at the 5th District Police Station Lockup at 727 East 111th Street, Chicago, Illinois, Police Officer MeShay Owens failed to ensure the safety and/or security of Dewone McClendon, a juvenile arrestee, who was injured while in Officer Owens' custody.
 - (B) The Superintendent did not prove by a preponderance of evidence that on or about October 20, 2004, at approximately 1900 hours, at the 5th District Police Station Lockup at 727 East 111th Street,

Chicago, Illinois, Police Officer MeShay Owens observed

Detention Aide Brian Pemberton push juvenile arrestee

Dewone McClendon's head down to a table causing McClendon's chin to strike the table and causing a laceration to McClendon's chin, and/or failed to report Detention Aide Pemberton's misconduct.

- (5) Respondent, Police Officer MeShay Owens, Star #7737, as charged herein, is **not guilty** to wit:
- Rule 6: Disobedience of an order or directive, whether written or oral.
 - (A) The Superintendent did not prove by a preponderance of evidence that on or about October 20, 2004, at approximately 1900 hours, at the 5th District Police Station Lockup at 727 East 111th Street, Chicago, Illinois, Police Officer MeShay Owens failed to ensure the safety and/or security of Dewone McClendon, a juvenile arrestee, who was injured while in Officer Owens' custody, contrary to General Order 02-03-01, Section II A.
 - (B) The Superintendent did not prove by a preponderance of evidence that on or about October 20, 2004, at approximately 1900 hours, at the 5th District Police Station Lockup at 727 East 111th Street, Chicago, Illinois, Police Officer MeShay Owens observed Detention Aide Brian Pemberton push juvenile arrestee Dewone McClendon's head down to a table, causing McClendon's chin to

strike the table and causing a laceration to McClendon's chin, and failed to report Detention Aide Pemberton's misconduct, contrary to General Order 93-03-02B, Section II.B.1..

- (6) Respondent, Police Officer MeShay Owens, Star #7737, as charged herein, is **not guilty** of violating, to-wit:
- Rule 22: Failure to report to the Department any violation of Rules and Regulations or any other improper conduct which is contrary to the policy, orders or directives of the Department.

The Superintendent did not prove by a preponderance of evidence that on or about October 20, 2004, at approximately 1900 hours, at the 5th District Police Station Lockup at 727 East 111th Street, Chicago, Illinois, Police Officer Owens observed Detention Aide Brian Pemberton push juvenile arrestee Dewone McClendon's head down to a table, causing McClendon's chin to strike the table and causing a laceration to McClendon's chin, and/or failed to report Detention Aide Pemberton's misconduct.

BY REASON of the findings set forth herein, cause exists for restoring the Respondent, Police Officer MeShay Owens, Star No. 7737, to her position as a police officer with the Department of Police, and to the services of the City of Chicago, with all rights and benefits effective January 6, 2007.


