FINDINGS

On June 6, 2007, the Superintendent of Police filed with the Police Board of the City of Chicago charges against Police Officer Lorenzo Shockley, Star No. 5302 (hereinafter sometimes referred to as "Respondent"), recommending that the Respondent be discharged from the Chicago Police Department for violating the following Rules of Conduct:

Rule 1: Violation of any law or ordinance.

Rule 2: Any action or conduct which impedes the Department's efforts to achieve

its policy and goals or brings discredit upon the Department.

Rule 4: Any conduct or action taken to use the official position for personal gain or

influence.

<u>Rule 6</u>: Disobedience of an order or directive, whether written or oral.

Rule 13: Failure to adequately secure and care for Department property.

Rule 14: Making a false report, written or oral.

Rule 21: Failure to report promptly to the Department any information concerning

any crime or other unlawful action.

The Police Board caused a hearing of these charges against Police Officer Lorenzo Shockley to be had before Thomas E. Johnson, Hearing Officer of the Police Board, on April 27, April 28, and May 13, 2009.

Following the hearing, the members of the Police Board read and reviewed the record of proceedings and viewed the video-recording of the testimony of the witnesses. Hearing Officer Johnson made an oral report to and conferred with the Police Board before it rendered a decision.

The Police Board of the City of Chicago, as a result of its hearing of the charges, finds and determines that:

- 1. The Respondent was at all times mentioned herein employed as a police officer by the Department of Police of the City of Chicago.
- 2. The charges were filed in writing and a Notice, stating the time, date, and place, when and where a hearing of the charges was to be held, together with a copy of the original charges, were served upon the Respondent more than five (5) days prior to the hearing on the charges.
- 3. Throughout the hearing of the charges the Respondent appeared in person and was represented by legal counsel.
- 4. The Respondent, Police Officer Lorenzo Shockley, Star No. 5302, charged herein, is **not guilty** of violating, to wit:

Rule 1: Violation of any law or ordinance,

in that:

The Superintendent did not prove by a preponderance of the evidence that from on or about February 1, 2005, through on or about March 31, 2005, or on one or more dates therein, the Respondent, a public employee, knowingly performed an act which he knew he was forbidden by law to perform, in that he gave Darryl Shockley and/or caused Darryl Shockley to take possession of the Respondent's Chicago Police Department Star, Star No. 19234, in violation of 720 ILCS 5/33(b) and/or 720 ILCS 32-5.1.

5. The Respondent, Police Officer Lorenzo Shockley, Star No. 5302, charged herein, is guilty of violating, to wit:

Rule 2: Any action or conduct which impedes the Department's efforts to achieve its policy and goals or brings discredit upon the Department,

in that:

Count I: From on or about February 1, 2005, through on or about March 31, 2005, or on one or more dates therein, the Respondent made verbal statements and/or otherwise represented to other Chicago Police Department members that Darryl Shockley or Darryl Henderson was a Chicago Police Officer for the purpose of securing employment at the "Rink," thereby impeding the Department's efforts to achieve its policy and goals and/or bringing discredit upon the Department.

Count V: From on or about February 1, 2005, through on or about March 31, 2005, or on one or more dates therein, in the vicinity of 1122 East 87th Street, Chicago, the

Respondent was present and/or was working security while Darryl Shockley or Darryl Henderson impersonated a Chicago Police Department Officer and/or displayed a Chicago Police Department Star, Star No. 19234, and the Respondent failed to make a report to the Chicago Police Department, thereby impeding the Department's efforts to achieve its policy and goals and/or bringing discredit upon the Department.

6. The Respondent, Police Officer Lorenzo Shockley, Star No. 5302, charged herein, is **not guilty** of violating, to wit:

Rule 2: Any action or conduct which impedes the Department's efforts to achieve its policy and goals or brings discredit upon the Department,

in that:

Count II: There was insufficient evidence presented that the Respondent was given proper notice that the criminal segment of the investigation had been concluded on or before August 25, 2006, and therefore the Superintendent did not prove by a preponderance of the evidence that on August 25, 2006, in the office of the Internal Affairs Division, the Respondent improperly refused to answer when Sergeant Brenda Dunn gave him a direct order to respond to questions asked of him as part of an Internal Affairs Division investigation.

Count III: There was insufficient evidence presented that the Respondent was given proper notice that the criminal segment of the investigation had been concluded on or before November 17, 2006, and therefore the Superintendent did not prove by a preponderance of the evidence that on November 17, 2006, in the office of the Internal Affairs Division, the Respondent improperly refused to answer when Sergeant Brenda Dunn gave him a direct order to respond to questions asked of him as part of an Internal Affairs Division investigation.

Count IV: The Superintendent did not prove by a preponderance of the evidence that from on or about February 1, 2005, through on or about March 31, 2005, or on one or more dates therein, the Respondent gave Darryl Shockley and/or caused Darryl Shockley to take possession of the Respondent's Chicago Police Department Star, Star No. 19234, thereby impeding the Department's efforts to achieve its policy and goals and/or bringing discredit upon the Department.

7. The Respondent, Police Officer Lorenzo Shockley, Star No. 5302, charged herein, is guilty of violating, to wit:

Rule 4: Any conduct or action taken to use the official position for personal gain or influence,

in that:

From on or about February 1, 2005, through on or about March 31, 2005, or on one or more dates therein, the Respondent made verbal statements and/or otherwise represented

to other Chicago Police Department members that Darryl Shockley or Darryl Henderson was a Chicago Police Officer for the purpose of securing employment at the "Rink," thereby using his official position for personal gain or influence.

8. The Respondent, Police Officer Lorenzo Shockley, Star No. 5302, charged herein, is **not guilty** of violating, to wit:

Rule 6: Disobedience of an order or directive, whether written or oral,

in that:

Count I: There was insufficient evidence presented that the Respondent was given proper notice that the criminal segment of the investigation had been concluded on or before August 25, 2006, and therefore the Superintendent did not prove by a preponderance of the evidence that on August 25, 2006, in the office of the Internal Affairs Division, the Respondent improperly refused to answer when Sergeant Brenda Dunn gave him a direct order to respond to questions asked of him as part of an Internal Affairs Division investigation.

Count II: There was insufficient evidence presented that the Respondent was given proper notice that the criminal segment of the investigation had been concluded on or before November 17, 2006, and therefore the Superintendent did not prove by a preponderance of the evidence that on November 17, 2006, in the office of the Internal Affairs Division, the Respondent improperly refused to answer when Sergeant Brenda Dunn gave him a direct order to respond to questions asked of him as part of an Internal Affairs Division investigation.

9. The Respondent, Police Officer Lorenzo Shockley, Star No. 5302, charged herein, is **not guilty** of violating, to wit:

Rule 13: Failure to adequately secure and care for Department property,

in that:

The Superintendent did not prove by a preponderance of the evidence that from on or about February 1, 2005, through on or about March 31, 2005, or on one or more dates therein, the Respondent gave Darryl Shockley and/or caused Darryl Shockley to take possession of the Respondent's Chicago Police Department Star, Star No. 19234, thereby failing to adequately secure and care for Department property.

10. The Respondent, Police Officer Lorenzo Shockley, Star No. 5302, charged herein, is **not guilty** of violating, to wit:

Rule 14: Making a false report, written or oral,

in that:

The Superintendent did not prove by a preponderance of the evidence that on or about May 21, 2000, the Respondent made a false report, written or oral, in that he filed a Chicago Police Department Lost and Found Report, reporting that his Chicago Police Department Star, Star No. 19234, was lost, however, Star No. 19234 was observed and/or found in the possession of Darryl Shockley on or about February 1, 2005, through on or about March 31, 2005, or on one or more dates therein.

11. The Respondent, Police Officer Lorenzo Shockley, Star No. 5302, charged herein, is guilty of violating, to wit:

Rule 21:

Failure to report promptly to the Department any information concerning any crime or other unlawful action,

in that:

From on or about February 1, 2005, through on or about March 31, 2005, or on one or more dates therein, in the vicinity of 1122 East 87th Street, Chicago, the Respondent was present and/or was working security while Darryl Shockley or Darryl Henderson impersonated a Chicago Police Department Officer and/or displayed a Chicago Police Department Star, Star No. 19234, and the Respondent failed to make a report to the Chicago Police Department that Darryl Shockley was falsely impersonating a peace officer in violation of 720 ILCS 5/32-5.1, thereby failing to report promptly to the Department any information concerning any crime or other unlawful action.

When a police officer knows that a civilian is impersonating a police officer and the police officer fails to take appropriate action, but rather facilitates this impersonation by statements made, this misconduct alone is sufficient cause for discharge. Therefore, by reason of the findings of fact and guilt to the extent set forth herein, cause exists for the discharge of the Respondent, Police Officer Lorenzo Shockley, Star No. 5302, from his position as a police officer with the Department of Police, and from the services of the City of Chicago.



From on or about February 1, 2005, through on or about March 31, 2005, or on one or more dates therein, in the vicinity of 1122 E. 87th Street, Chicago, Illinois, Officer Lorenzo Shockley was present and/or was working security while Darryl Shockley or Darryl Henderson impersonated a Chicago Police Department Officer and/or displayed a Chicago Police Department Star, Star Number 19234, and failed to make a report to the Chicago Police Department, thereby impeding the Department's efforts to achieve its policy and goals or bringing discredit upon the Department.

Rule 4:

Police Officer Lorenzo Shockley, Star Number 5302, is charged with violating Rule 4, "Any conduct or action taken to use the official position for personal gain or influence," in the following instance:

Count I:

From on or about February 1, 2005, through on or about March 31, 2005, or on one or more dates therein, Officer Lorenzo Shockley made verbal statements and/or otherwise represented to other Chicago Police Department members, that Darryl Shockley or Darryl Henderson, was a

Chicago Police Officer for the purpose of securing employment at the "Rink," thereby using his official position for personal gain or influence.

Rule 6: Police Officer Lorenzo Shockley, Star Number 5302, is charged with violating Rule 6, "Disobedience of an order or directive, whether written or oral," in one or more of the following instances:

Count I: On or about August 25, 2006, in the Office of the Internal Affairs Division, Sergeant Brenda Dunn gave Officer Lorenzo Shockley a direct order to respond to questions asked of him as part of an Internal Affairs Division investigation, and Officer Lorenzo Shockley refused to answer, thereby disobeying an order or directive, whether written or oral.

Count II: On or about November 17, 2006, in the Office of the Internal Affairs Division, Sergeant Brenda Dunn gave Officer Lorenzo Shockley a direct order to respond to questions asked of him as part of an Internal Affairs Division investigation, and Officer Lorenzo Shockley refused to answer, thereby disobeying an order or directive, whether written or oral.

Rule 13: Police Officer Lorenzo Shockley, Star Number 5302, is charged with violating Rule 13, "Failure adequately to secure and care for Department property," in the following instance:

Count I: From on or about February 1, 2005, through on or about March 31, 2005, or on one or more dates therein, Officer Lorenzo Shockley gave Darryl Shockley and/or caused Darryl Shockley to take possession of his Chicago Police Department Star, Star Number 19234, thereby failing adequately to secure and care for Department property.

Rule 14: Police Officer Lorenzo Shockley, Star Number 5302, is charged with violating Rule 14, "Making a false report, written or oral," in the following instance:

Count I: On or about May 21, 2000, Officer Lorenzo Shockley filed a Lost and Found Chicago Police Department Report, reporting that his Chicago Police Department Star, Star Number 19234, was lost, however, Star Number 19234 was observed and/or found in the possession of Darryl Shockley on or about February 1, 2005, through on or about March 31, 2005, or on one or more dates therein, thereby making a false report, whether written or oral.

Rule 21:

Police Officer Lorenzo Shockley, Star Number 5302, is charged with violating Rule 21, "Failure to report promptly to the Department any information concerning any crime or other unlawful action," in the following instance:

Count I:

From on or about February 1, 2005, through on or about March 31, 2005, or on one or more dates therein, in the vicinity of 1122 E. 87th Street, Chicago, Illinois, Officer Lorenzo Shockley was present and/or was working security while Darryl Shockley or Darryl Henderson impersonated a Chicago Police Department Officer and/or displayed a Chicago Police Department Star, Star Number 19234, and failed to make a report to the Chicago Police Department that Darryl Shockley was falsely personating a peace officer in violation of 720 ILCS 5/32-5.1., thereby failing to report promptly to the Department any information concerning any crime or other unlawful action.

Based on the foregoing charges and specifications, the Superintendent recommends that Police Officer Lorenzo Shockley, Star Number 5302, be discharged from the Chicago Police Department.
