FINDINGS

On October 24, 2007, the Superintendent of Police filed with the Police Board of the City of Chicago charges against Police Officer Crystal Bell, Star No. 9720, (hereinafter sometimes referred to as "Respondent") recommending that the Respondent be discharged from the Chicago Police Department for violating the following Rules of Conduct:

RULE 1: Violation of any law or ordinance.

RULE 2: Any action or conduct which impedes the Department's efforts to achieve its policy and goals or brings discredit

upon the Department.

RULE 6: Disobedience of an order or directive, whether written or

oral.

The Police Board of the City of Chicago caused a hearing on these charges against Police Officer Crystal Bell, Star No. 9720, to be heard by Jacqueline A. Walker, Hearing Officer of the Police Board of the City of Chicago, on April 4, 2008, and April, 11, 2008. Following the Hearing, the members of the Police Board read and reviewed the certified transcription of the proceedings of the hearing and viewed the video-recordings of the proceedings. Jacqueline A. Walker, Hearing Officer made an oral report to and conferred with the Police Board before it rendered a decision.

As a result of the foregoing, the Police Board of the City of Chicago finds and determines that:

- (1) The Respondent was, at all times mentioned herein, a police officer employed by the Department of Police of the City of Chicago.
- (2) The charges were filed, in writing, and a Notice, stating the time, date and place, when and where a hearing on the charges was to be held, together with a copy of the original charges were served upon the Respondent more than five (5) days prior to the hearing on the charges.
- (3) Throughout the hearing the Respondent appeared in person and was represented by legal counsel.
- (4) Respondent, Police Officer Crystal Bell, Star #9720, as charged herein, is **not** guilty of violating, to-wit:

<u>Rule 1:</u> Violation of any law or ordinance, in that:

The Superintendent did not prove by a preponderance of evidence that on or about February 22, 2007, she provided a urine specimen which contained codeine, thereby violating Illinois Complied Statutes, Chapter 720, Section 570/402, by possessing some amount of codeine on or before February 22, 2007.

- (5) Respondent, Police Officer Crystal Bell, Star #9720, as charged herein, is **not** guilty to wit:
- Rule 2: Any action or conduct which impedes the Department's efforts to achieve its policy and goals or brings discredit upon the Department, in that:

The Superintendent did not prove by a preponderance of evidence that on or about February 22, 2007, she provided a urine specimen which contained codeine, thereby impeding the Department's

efforts to achieve its policy and goals and/or bringing discredit

upon the Department.

(6) Respondent, Police Officer Crystal Bell, Star No. 9720, as charged herein, is

not guilty to wit:

Rule 6: Disobedience of an order or directive, whether written or oral, in that:

The Superintendent did not prove by a preponderance of evidence

that on or about February 22, 2007, she provided a urine specimen

which contained codeine, thereby violating Administrative Special

Order 05-01 Article III, Section B.

BY REASON of the findings set forth herein, cause exists for restoring the

Respondent, Police Officer Crystal Bell, Star No. 9720, to her position as a police officer

with the Department of Police, and to the services of the City of Chicago, with all rights

and benefits, effective October 26, 2007.
