**MEMORANDUM AND ORDER**

On December 13, 2012, the Superintendent of Police filed with the Police Board of the City of Chicago charges against Police Officer Edward Feliciano, Star No. 17238 (hereinafter sometimes referred to as “Respondent”), recommending that the Respondent be discharged from the Chicago Police Department for violating various Rules of Conduct.

On April 18, 2013, the Police Board found the Respondent guilty of violating Rules 1, 2, 8, and 9, and ordered that the Respondent be suspended from his position as a police officer. The Board further ordered the Respondent to successfully complete anger-management counseling in order to be eligible for reinstatement to his position as a police officer.

On June 24, 2013, the Respondent filed with the Board a Request for Reinstatement. The Superintendent filed a Response and filed a Motion to Supplement the Superintendent’s Response. The Respondent filed a Reply. The Superintendent’s Motion to Supplement is granted. The Board has considered the Respondent’s Request, the Superintendent’s Response as supplemented, and the Respondent’s Reply.

Based on the report of Dr. Robert Sobo, a psychologist in the Chicago Police Department’s Professional Counseling Service/Employee Assistance Program, regarding the counseling Officer Feliciano has completed under his care in the Police Department’s Professional Counseling Service/Employee Assistance Program since the Board issued its Findings and Decision in this matter, the Board determines that Officer Feliciano has completed sufficient counseling to comply with the Board’s order.

**POLICE BOARD ORDER**

**IT IS HEREBY ORDERED**, for the reasons set forth above, that the Respondent's Request for Reinstatement is **granted**, and that the Respondent, Police Officer Edward Feliciano, Star No. 17238, is **reinstated** to his position as a police officer with the Department of Police, and to the services of the City of Chicago, effective July 23, 2013.
