

CHARGES

Gang Crimes Specialist Joseph J. Miedzianowski, Star Number 60015, is charged with violating the following rules contained in Article V of the Rules and Regulations of the Chicago Police Department, which were in full force and effect on the date(s) of the alleged violations:

- Rule 1: Violation of any law or ordinance.
- Rule 2: Any action or conduct which impedes the Department's efforts to achieve its policy and goals or brings discredit upon the Department.
- Rule 4: Any conduct or action taken to use the official position for personal gain or influence.

SPECIFICATIONS

Gang Crimes Specialist (GCS) Joseph J. Miedzianowski, Star Number 60015, is charged with violating Rule 1, "Violation of any law or ordinance," in the following instance:

From about 1995 until December 1998, or for some period of time therein, GCS Miedzianowski conspired with others, to possess with the intent to distribute and to distribute, kilogram quantities of cocaine and quantities of heroin, in violation of Title 21, United States Code, Section 846.


Gang Crimes Specialist (GCS) Joseph J. Miedzianowski, Star Number 60015, is charged with violating Rule 2, "Any action or conduct which impedes the Department's efforts to achieve its policy and goals or brings discredit upon the Department," in the following instance:

- Count I: From about 1995 until December 1998, or for some period of time therein, GCS Miedzianowski conspired with others, to possess with the intent to distribute and to distribute, kilogram quantities of cocaine and quantities of heroin.
- Count II: From about 1995 until December 1998, or for some period of time therein, GCS Miedzianowski used his official position as a Chicago Police Officer to conspire with others, to possess with the intent to distribute and to distribute, cocaine and heroin, and/or to protect the distribution of narcotics by interfering with legitimate law enforcement units, thereby using his official position for personal gain and influence.

Gang Crimes Specialist (GCS) Joseph J. Miedzianowski, Star Number 60015, is charged with violating Rule 4, "Any conduct or action taken to use the official position for personal gain or influence," in the following instance:

From about 1995 until December 1998, or for some period of time therein, GCS Miedzianowski used his position as a Chicago Police Officer to conspire with others, to possess with the intent to distribute and to distribute, kilogram quantities of cocaine and quantities of heroin, and/or to protect the distribution of narcotics by interfering with legitimate law enforcement units, thereby using his official position for personal gain and influence.

Based on the foregoing charges and specifications, the Superintendent of Police recommends that Gang Crimes Specialist Joseph J. Miedzianowski, Star Number 60015, be discharged from the Chicago Police Department.
