## FINDINGS AND DECISION

On June 24, 1999, the Superintendent of Police filed charges with the Chicago Police Board against Police Officer James C.

Adams, Star No. 6045, CR. No. 249954, henceforth sometimes referred to as "Respondent," for violation of the following Department Rules:

Rule 1: Violation of any law or ordinance.

Rule 2: Any action or conduct which impedes the Department's efforts to achieve its policy and goals or brings discredit upon the Department.

Rule 6: Disobedience of an order or directive, whether written or oral.

Hearings on the charges were conducted by Hearing Officer Cornelia Wallis Honchar on March 16 and April 21, 2000. Final arguments were presented before Hearing Officer Thomas Johnson on June 20, 2000. The members of the Chicago Police Board read and reviewed the certified transcripts of the hearings and the evidence admitted. Hearing Officers Honchar and Johnson made oral reports of the hearings and conferred with the Police Board before it rendered its decision.

The Chicago Police Board finds and determines that:

The Respondent was, at all times mentioned herein, a Police Officer employed by the City of Chicago Department of Police. Police Officer James C. Adams Star No. 6045/ P.B. Case 99-2380 Page 2

- 2) The charges were filed in writing, and a Notice, stating the time, date and place, when and where a hearing on the charges was to be held, together with a copy of the original and amended charges were served on the Respondent more than five (5) days before the hearing on the charges.
- 3) Throughout the proceedings the Respondent appeared in person and was represented by legal counsel.
- 4) The Respondent, James C. Adams, Star No. 6045, is not guilty of violating Rule 1, "Violation of any law or ordinance,"

Count I: On November 16, 1998, Officer Adams rendered a urine specimen, which did not contain marijuana metabolites, thus did not evidence possession and/or ingestion and/or some type of marijuana use, and did not thereby violate Chapter 720 ILCS 550/4, by possessing some amount of marijuana on or before November 16,1998, and did not thereby violate a law.

The Respondent, James C. Adams, Star No. 6045, is not guilty of violating Rule 2, "Any action or conduct which impedes the Department's efforts to achieve its policy and goals or brings discredit upon the Department,"

On November 16, 1998, Officer Adams rendered a urine specimen, which did not contain marijuana metabolites, thus did not evidence possession and/or ingestion and/or use

of marijuana, and thereby did not impede the Department's efforts to achieve its policy and goals and/or did not bring discredit upon the Department.

The Respondent, James C. Adams, Star No. 6045, is not guilty of violating Rule 6. "Disobedience of an order or directive, whether written or oral,"

On November 16, 1998, Officer Adams rendered a urine specimen, which did not contain marijuana metabolites, thus did not evidence possession and/or ingestion and/or some type of marijuana use, and thereby did not violate General Order 90-5, Article III, Section B.


